



Values/Virtues (Social Safety Nets)





TIMELINE OF CONGRESSIONAL ACTS







Intergenerational Trauma



- Every Native has a parent, grandparent or great grandparent attended Boarding Schools
- "Trauma affects genetic processes, leading to traumatic reactivity being heightened in populations who experience a great deal of trauma"

- Proper Assessment is important
 - Domestic Violence
 - Substance Use
 - Cultural strengths
 - Many vulnerabilities put youth and others at risk of drugs, trafficking and sexual assault.
 - 2016 study by National Institute of Justice (NIJ) the most comprehensive study to date
 - Violence Against American Indian and Alaska Native Women and Men | National Institute of Justice

Current Impacts of Indian Boarding School

The Federal In Boarding School over, but the patterns of abuse are not.

American Indian and Alaska Natives have higher rates of:

- Suicide
- O PTSD
- Violence
- Alcohol-related deaths
- O Drunk driving accidents
- O Substance use and dependence

Native children are

as likely to experience serious psychological distress

as likely to be in foster care

In Minnesota, that number jumps to 15x (NICWA, 2021)

Native women are



as likely to be raped

as likely to be murdered

reports of missing American Indian and Alaska Native women and girls in 2016, but only 116 cases were filed in the Department of Justice federal missing person database.

Government stepped in

Savannah's Act 2017-Savannah Greywind 22yrs old murdered 8 months pregnant, bipartisan, improve federal response to MMIP, increasing coordination among Federal, State, Tribal, & local law enforcement agencies. signed in October 2020.-<u>Tribal Justice and Safety | About DOJ Efforts to Address MMIP</u>.

► WHY?

- "American Indian & Alaska Native girls/women experience some of the highest rates of DV & abuse in the US, yet policy change, funding, and advocacy has been slow to address high DV rates".- Domestic violence in American Indian and Alaska Native populations: a new framework for policy change and addressing the structural determinants of health PMC
- Native women & girls experience disproportionately high rates of sexual & gender-based violence, including intimate partner violence. Native MEN experience higher rates of violence, such as murder, sexual, and psychological violence, than other demographic groups.

- ► Homicide, **3rd leading cause of death** of American Indian & Alaska Native (AI/AN) girls 15yrs-19yrs & AI/AN women 20yrs to 24yrs in **2019**. It was the **4th leading cause** of AI/AN women 25yrs-34yrs in same year (Heron, 2021).
- Murder rate for AI/AN women is nearly 3x higher than non-Hispanic White women (Petrosky et al., 2017). Study of 16 states found that AI/AN women who were victims of intimate partner violence lost an average of 38.3 potential years of life per death (Graham et al., 2021).


Assimilation

- Attends ceremonies


- Assimilated

IMPORTANT TO RESPECT TRIBAL JURISDICTIONS

Nebraska breakdown

- ▶ 3 Sovereigns
 - ▶ Federal
 - State
 - ▶ Tribal
- No easy answer and complicated Checkerboard jurisdiction-County/State/NSP, Tribal Bureau of Indian Affairs (BIA) office in Winnebago, Federal (FBI)
- Tribal cops can arrest to prevent harm and remove from Reservation-can't hold not enough facilities most cant arrest non-natives

LB1288 (2024)

Created ability for the use of tribal enrollment cards for proof of age and identity for certain firearm and alcohol laws



Provided recognition of tribal mental health and dangerous sex offender commitment orders as prescribed



Provided tribal law enforcement officers ability to take a subject into emergency protective custody, to transport and commit that persons under tribal law. Also covered payment of related costs.

Tribal Court Protection Orders

Nebraska Enforcement of Tribal Court Protection Orders



Native American AccessLine 800-729-9908

- Tribal courts have full jurisdiction to issue protection orders, and the law requires Nebraska to recognize and enforce tribal protection orders. 18 U.S.C. § 2265; Neb. Rev. Stat. § 42-391.
- If a law enforcement officer determines there is probable cause to believe a valid tribal protection order exists and has been violated, the officer "shall" arrest the violator. Neb. Rev. Stat. §§ 42-935(a), 42-928.
- If the officer is shown a paper or electronic copy of a current tribal protection order, the officer has probable cause to believe a valid tribal protection order exists. Neb. Rev. Stat. § 42-935(a).
- Many tribal protection orders are registered in the Nebraska Foreign Protection Order Registry, and can be seen in the National Crime Information Center (NCIC) database.



>LB 154 (2019)

- Statement and Report
 - Scope of the problem-misclassification
 - Identify barriers
 - Create partnerships to reporting & investigation of missing Native American women
 - Section NSP website for Native American
 - less than 1% of pop, NE missing at rate 3x of NE population

What did LB 154 create?

- ► LB154 passed in 2019:

 - Led to the creation of the LB154 Report
- Nebraska Commission on Indian Affairs Statement on LB 154 Report: Statement-and-Report.pdf
 - "Seek funding for a new, full-time staff position to manage the Task Force operations. This staffer will report to the Executive Director of the Nebraska Commission on Indian Affairs.
 - Led to the drafting of LB328

 - Did not pass but AG's Office agreed to house a position (MMIP Liaison) in our office that addressed the efforts.

What does MMIP look like in Nebraska?



2024, Nebraska has reported 43 active cases of MMIP, nearly doubling from 23 cases in 2020. Increase due to improved data collection & awareness, rather than a surge in disappearances.

Key Statistics:

- Disproportionate Representation: Native Americans constitute approximately 1.5% of Nebraska's population but account for about 4.6% of the state's missing persons cases.
- Youth Impact: A significant majority of missing Native Americans in Nebraska are males under the age of 17.
- Resolution Rates: Many missing Native individuals are found; for instance, a study noted that 68.4% of Native American missing persons cases identified on January 20 were no longer listed as missing just over two months later, on March 31.

First Steps for Families:

- · Immediately call 911 there is no waiting period to report.
- When you call 911, let them know the missing person is native and be prepared to provide them with a detailed description of your loved one, including:
 - Name
- Weight
- · Recent, unfiltered photo
- Date of Birth
 Scars/tattoos
- Last known location

- Height
- Tribal affiliation Last seen wearing

Next:

- Keep records of your report, including the report taker, case number, investigator, phone number, and contact information.
- Choose a spokesperson from your family who will communicate any updates in the case.
- · Reach out to family and friends to help raise awareness.
- · Make a flyer with information about your loved one. A template is available at AGO.Nebraska.gov/MMIP.








DOJ Template

- Guide for tribes to create response plans
 - Made up of 4 Sections
 - > Law Enforcement
 - Victim Services
 - > Outreach Public
 - Media Communications
- Can have 1 Tribal working group or multiple working groups.

Include Native voices in case decisions as much as possible

Community & Breaking the Cycle of violence

- Support Gathering of Nations (GONA) events-
- Support community Healing from Historical Trauma and unresolved Grief, provide a safe place to share, heal and plan for action
- Incorporate Native Language- maximize existing healthy social structures/supports though schools etc.,
- Programming that meets community needs:
 - Culturally & Spiritually based program,
 - Reentry programming
 - Treat Mental and Substance Use D/O as Chronic Medical Conditions
 - ► Suicide prevention
 - Promote Tribal healing to Wellness courts, recovery vs punishing

Community & Breaking the Cycle of violence


- ▶ Promote Traditional Parenting

 Teach on Post-partem
 Depression


