## Get the information you need

The Nebraska Court Improvement Project created two resources to help kids learn what happens in both child welfare cases (when kids are taken from unsafe homes) and juvenile justice cases (when a kid is in court because someone said they broke a law).



Both books describe who is involved in the things going on, what things might be happening, what rights you have, and who you can contact with questions or problems.

## Child Welfare

The first book covers the Child Welfare process. If the State believes children are not safe in their home, they will file charges against parents. The court will hear the evidence and decide if there was any **abuse** or **neglect** going on. **You have a right to be involved and to be listened to.** This book will show you what you can do to be heard.

## Juvenile Justice

The second book covers the Juvenile Justice process. If the State believes a child has broken the law, charges will be filed and a judge will hear the evidence in court. If the judge decides you did break the law, he will hand down a disposition. A disposition may include probation or some other corrective action and a plan to get you back on the right track.

## Other Resources & Planning for Your Future

Both books have sections that go over some of the things kids need to think about as they transition into being an adult and pages of resources - people and agencies you can contact for more help. There are lots of things you need to do when you're an adult that don't seem very important to you as a kid. But you do need to learn about those adult things as you grow up.

There are lots of people you will meet along the process. They all want to see you succeed and be the best person you can be. They all want to help you through the process. These books will help you understand those processes and what you can do to help yourself.
