
COMPLETING THE PETITION FOR NAME CHANGE OF A MINOR CHILD OR CHILDREN

Use this form to ask to legally change the name(s) of your minor child or children. You may change their first, middle, and/or last names.

There are specific requirements to be able to file the Petition (request).
