

## COMPLETING THE LEGAL NOTICE FOR NAME CHANGE OF A MINOR CHILD

The Legal Notice for Name Change of A Minor Child must be printed in the newspaper once a week for two weeks in a row.

It must be in a newspaper printed in the county where the Petition is filed. If there isn't a newspaper printed in that county, it can be in a newspaper printed in this state and generally circulated in that county.

Use this form to give the newspaper the information to print.

Enter the county where the Petition was filed.

Enter the case number.

Enter the children's CURRENT first, middle, and last name(s).

Enter the children's CURRENT first, middle, and last name(s).

Enter the date filed and the county the Petition was filed in.
