#### 2025 CEUS

Continuing education is required by the Nebraska Judicial Branch to ensure that certified, provisionally certified, and registered interpreters maintain and improve their interpreting skills. <u>Annual Interpreter Continuing Education Compliance Form</u> for January 1, 2025- December 31, 2025, **are due no later than February 1, 2026.** Annual CEU submission is a condition to remain on the Statewide Register of Interpreters. A big thank you to those interpreters who have already submitted their forms – way to be on top of it!!

- Foreign language interpreters shall complete and report 5 credit hours of approved continuing education every year. At least 2 continuing education hours must be earned in professional responsibility.
- Every certified Sign Language and CDI must complete and report the RID required 20 contact hours with the minimum of 15 hours in Professional Studies.
- Every non-certified Sign Language and DI must complete and report the NCDHH required 12 clock hours with a minimum of 9 hours in Professional Studies and 1.5 hours in interpreter ethics

# **Remote Hearings**

When interpreting in a remote video assignment, interpreters are to have their display name as first name, last name, the word interpreter, and language (see example below).

## Example: John Doe Interpreter Kinyarwanda

This ensures the correct spelling of the interpreter's name for the court record and allows staff to quickly identify the individuals they need to let into the hearing.

## **Tax Documents**

State Accounting will mail out the 1099s by January 31st. The minimum amount an individual needs to earn to receive a 1099 is \$600. If you have questions or do not receive your 1099 by the beginning of February, you can reach State Accounting directly at (402)471-2581.
