Interpreter Statements

- Effective 1/1/26, mileage reimbursement has increased to \$0.725/mile. Shred all old Statements and use this updated [Interpreter Statement](#).
- You must number all your remote appearance confirmations before submitting your Statement.
- Did you review the corrections made on your Statement? Do you understand why they were made? If not, please ask because we need you filling out your Statements correctly.
- When you do a Probation translation, ensure you clearly note the time it took you on your Statement and that it was for Probation so that cost can be allocated to them.
- Due to the volume of corrections made on Statements, Finance will have the revision emails out by the end of the month, instead of the 19th
 - Revisions are any corrections made to an amount
 - If an interpreter leaves the calculations at the bottom blank, they will be tallied and filled in, but this does not rise to the level of a revision and would not necessitate the interpreter receiving a revision email

State Accounting will mail out the 1099s by January 31st. The minimum amount an individual needs to earn to receive a 1099 is \$600. If you have questions or do not receive your 1099 by the beginning of February, you can reach State Accounting directly at (402)471-2581.
