Stat. § 25-1315(1) (Reissue 2016). Where § 25-1315 is implicated, one may bring an appeal pursuant to such section only when (1) multiple parties are present, (2) the court enters a "final order" within the meaning of Neb. Rev. Stat. § 25-1902 (Reissue 2016) as to one or more but fewer than all of the causes of action or parties, and (3) the trial court expressly directs the entry of such final order and expressly determines that there is no just reason for delay of an immediate appeal. Dylan H. v. Brooke C., 317 Neb. 264, 9 N.W.3d 439 (2024).
