We vacate all orders issued by that court issued after the date of the Appellee's death for lack of jurisdiction. See Muller v. Weeder, 313 Neb. 639, 986 N.W.2d 38 (2023). And where a lower court lacks jurisdiction to adjudicate the merits of a claim, issue, or question, an appellate court also lacks the power to determine the merits of the claim, issue, or question presented to the lower court.
