Appellee's motion for summary affirmance pursuant to Neb. Ct. R. App. P. § 2-107(B)(2) is granted. Appellant's habeas corpus petition asserts his life sentence is void because his conviction did not meet the mens rea of a Class IB felony; however, even a sentence outside of the period authorized by the relevant sentencing statute is merely erroneous and is not void. See Meyer v. Frakes, 294 Neb. 668, 884 N.W.2d 131 (2016). Habeas corpus will not lie upon the ground of mere errors and irregularities in the judgment or sentence rendering it not void, but only voidable. Id.
