Appeal dismissed for lack of jurisdiction pursuant to Neb. Ct. R. App. P. § 2-107(A)(1). The district court's July 10, 2025, Order Approving Sale and Payment of Sale Expenses does not constitute a rendition of final judgment as defined in Neb. Rev. Stat. § 25-301(2) (Cum. Supp. 2024), because the court did not yet sign "a single, signed written document stating all of the relief granted or denied in an action." D&M Roofing & Siding, 316 Neb. 952, 968, 7 N.W.3d 868, 881 (2004). "In the absence of such, a judgment has not yet been rendered." Id. at 972, 7 N.W.3d at 884. See also Elbert v. Keating, O'Gara, Nedved & Peter, 319 Neb. 390, 22 N.W.3d 671 (2025).
