Appellant's sentence is within the statutory range and there was no abuse of discretion by the trial court. See, State v. Price, 306 Neb. 38, 944 N.W.2d 279 (2020) (sentence not abuse of discretion when nothing indicates sentencing court considered inappropriate factors or ignored mitigating factors); State v. Earnest, 315 Neb. 527, 997 N.W.2d 589 (2023) (sentencing court is not required to articulate on record that it has considered each sentencing factor and to make specific findings as to facts that bear on each one).
