Mot. of Appellee for Summary Affirmance

Appellee's motion for summary affirmance is sustained. See Neb. Ct. R. App. P. § 2-107(B)(2). The sentence imposed was not an abuse of discretion. See State v. Alkazahy, 314 Neb. 406, 990 N.W.2d 740 (2023) (sentence imposed within statutory limits will not be disturbed on appeal in absence of abuse of discretion by trial court); State v. Greer, 309 Neb. 667, 962 N.W.2d 217 (2021) (sentencing court is not required to articulate on record that it has considered each sentencing factor nor make specific findings as to facts pertaining to factors or weight given them). Appellant also failed to properly preserve his claim of ineffective assistance of trial counsel. See State v. Miranda, 313 Neb. 358, 984 N.W.2d 261 (2023) (assignments of error on direct appeal regarding ineffective assistance of trial counsel must specifically allege deficient performance and appellate court will not scour remainder of brief in search of such specificity).
