Misc Submission to Court re Jurisdiction

Appeal dismissed. See Neb. Ct. R. App. P. § 2-107(A)(1). The orders of October 16, 2025, November 25, 2025, and January 8, 2026, fail to satisfy the requirements of Neb. Rev. Stat. § 25-1315(1) (Reissue 2016) and Neb. Rev. Stat. § 15-1301(2) (Cum. Supp. 2024). Specifically, there does not appear to have been an express determination regarding the claims against Mark Resseguie, personally, for breach of contract, negligence, and conversion. While the transcript shows that the Webster defendants were previously granted summary judgment in their favor on the claims for conversion and quantum meruit, the Nebraska Supreme Court has stated that all relief granted or denied in an action must be contained in a single written document to constitute a final judgment. See D&M Roofing & Siding v. Distribution, Inc., 316 Neb. 952, 7 N.W.3d 868 (2024).
