Stat. §§ 25-1329 (Reissue 2016) and 25-1912(3) (Cum. Supp. 2024). A party can move the court to vacate or modify a final order, but if the court does not grant the motion, a notice of appeal must be filed within 30 days of the entry of the earlier final order if the party intends to appeal it. Bryson L. v. Izabella L., 302 Neb. 145, 921 N.W.2d 829 (2019).
