Appellee's motion for summary affirmance pursuant to Neb. Ct. R. App. P. § 2-107(B)(2) is sustained; judgment affirmed. Appellant's sentence is within the statutory range and there was no abuse of discretion by the trial court. See State v. Price, 306 Neb. 38, 944 N.W.2d 279 (2020) (sentence not abuse of discretion when nothing indicates sentencing court considered inappropriate factors or ignored mitigating factors). Further, we decline to address appellant's assignment of error generally alleging ineffective assistance of trial counsel. See State v. Haas, 317 Neb. 919, 12 N.W.3d 787 (2024) (citing to State v. Mrza, 302 Neb. 931, 926 N.W.2d 79 (2019), for rule that assignments of error on direct appeal regarding ineffective assistance of trial counsel must specifically allege deficient performance; claim insufficiently raised will not be addressed on appeal).
