Elharras v. Lund Company

ROD Misc Submission to Court re Jurisdiction
Appeal dismissed for lack of jurisdiction pursuant to Neb. Ct. R. App. P. § 2-107(A)(1). Appellant's notice of appeal filed on January 16, 2026, was not filed within 30 days of the district court's order of dismissal entered on December 16, 2025. See Neb. Rev. Stat. § 25-1912(1) (Cum. Supp. 2024) (notice of appeal must be filed within 30 days after entry of judgment, decree, or final order). The appellant's motion filed on January 2, 2026, did not toll the time for filing an appeal from the December 16, 2025, final order whether viewed as a motion to vacate/reconsider or a motion to alter/amend. See, Bryson L. v. Izabella L., 302 Neb. 145, 921 N.W.2d 829 (2019) (party can move court to vacate or modify final order, but if court does not grant motion, notice of appeal must be filed within 30 days of entry of earlier final order); Neb. Rev. Stat. § 25-1329 (Reissue 2016) (motion to alter or amend judgment shall be filed no later than 10 days after entry of judgment).
