the order of March 26, 2026, did not state what relief has been
granted or denied as to defendant Lyons Rural Fire Protection
District. The court therefore has not yet rendered judgment. See D&M
Roofing & Siding v. Distribution, Inc., 316 Neb. 952, 7 N.W.3d 868
(2024). A new notice of appeal and poverty affidavit must be filed
within 30 days after the entry of a final order in this case. See Neb.
Rev. Stat. § 25-1912(1) (Cum. Supp. 2024).
