ROD Misc Submission to Court re Jurisdiction

Appeal dismissed for lack of jurisdiction. See Neb. Ct. R. App. P. § 2-107(A)(1). The district court's October 22, 2025, order contained findings that the parties' purchase agreement is unenforceable in part and that the remaining claims were waived at trial. However, the court did not plainly dismiss those claims, thus making a "final determination of the rights of the parties," as required by D&M Roofing & Siding v. Distribution, Inc., 316 Neb. 952, 7 N.W.3d 868 (2024).
